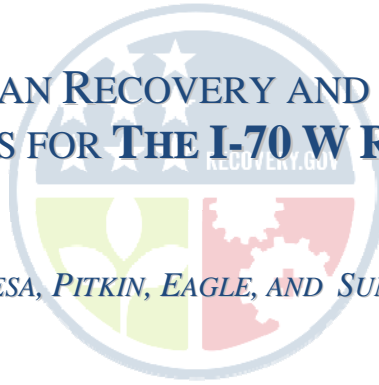


WHAT THE AMERICAN RECOVERY AND REINVESTMENT ACT MEANS FOR THE I-70 W REGION



GARFIELD, MESA, PITKIN, EAGLE, AND SUMMIT COUNTIES

Energy

The Recovery Act provides funding to improve the delivery of clean, renewable energy and to improve energy efficiency in homes and buildings across the state.

\$229,000 to City of Grand Junction

Law Enforcement

The Recovery Act provides funding to improve local and tribal law enforcement, to combat violence against women, to fight internet crimes against children, to improve the functioning of the criminal justice system, to assist victims of crime, and to support youth mentoring.

Helping Those Most Vulnerable

The Recovery Act provides funds for shelter, feeding, food distribution through food pantries and food banks, one-month assistance with rent, mortgage and utility payments to prevent evictions, and transition assistance.

Affordable Housing

The Recovery Act provides funding for affordable, quality housing for those who need it most.

Education

The Recovery Act provides funding to save teacher jobs, improve schools and ensure Colorado kids have access to a quality and competitive education.

Roads and Highway Improvement

The Recovery Act provides funding to create new jobs rebuilding and revamping Colorado's crumbling transportation infrastructure.

\$8,994,331 to State Highway 9 between Valley Brook and Coyne Valley in Breckenridge

\$8,000,000 to I-70 between Vail Pass and Silverthorne

\$2,014,973 to I-70 West, Truck Parking Management

\$1,339,467 to I-70 at Palisade Interchange

\$2,065,880 to State Highway 340 340 in Fruita

\$3,274,919 to I-70/State Highway 82/US 6 at the Glenwood Springs Interchange

\$10,821,276 to I-70 at the Edwards Interchange

\$3,800,000 to I-70B near Grand Junction (also known as Highway 6 and 50)

\$1,500,000 to Mesa County

\$4,000,000 to Aspen-Pitkin County Airport Improvements

\$8,000,000 to Grand Junction Airport Rehabilitation

Military and Veterans Construction

The Recovery Act provides funding to upgrade building facilities at military installations and VA healthcare facilities and cemeteries.

\$3,400,000 to Grand Junction VA Medical Center

Environment

The Recovery Act provides funding to projects for EPA Super Fund Clean-Up, Hazardous Fuels Reduction, USDA Forest Lands, and development of the Interior.

\$350,000 to Leadville Mine Drainage Tunnel - Assessment

\$300,000 to Leadville Mine Drainage Tunnel - Sludge Press Purchase

\$10,000,000 to Colorado River Basin Salinity Control Program
