A BILL

To extend the Secure Rural Schools and Community Self-Determination Act of 2000.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. EXTENSION OF SECURE RURAL SCHOOLS AND**
4 **COMMUNITY SELF-DETERMINATION ACT OF**
5 **2000.**

6 (a) SECURE PAYMENTS FOR STATES AND COUNTIES
7 CONTAINING FEDERAL LAND.—

8 (1) SECURE PAYMENTS.—Section 101 of the
9 Secure Rural Schools and Community Self-Deter-

1 mination Act of 2000 (16 U.S.C. 7111) is amended,
2 in subsections (a) and (b), by striking “and 2018”
3 each place it appears and inserting “2018, 2019,
4 and 2020”.

5 (2) PAYMENTS TO STATES AND COUNTIES.—

6 (A) ELECTION TO RECEIVE PAYMENT
7 AMOUNT.—Section 102(b) of the Secure Rural
8 Schools and Community Self-Determination Act
9 of 2000 (16 U.S.C. 7112(b)) is amended—

10 (i) in paragraph (1)(D)—

11 (I) in the paragraph heading, by
12 striking “FOR FISCAL YEARS 2017 AND
13 2018” and inserting “FOR EACH OF
14 FISCAL YEARS 2017 THROUGH 2020”;
15 and

16 (II) by striking “for fiscal years
17 2017 or 2018” and inserting “for
18 each of fiscal years 2017 through
19 2020”; and

20 (ii) in paragraph (2), in subpara-
21 graphs (A) and (B), by striking “for fiscal
22 years 2017 and 2018” each place it ap-
23 pears and inserting “for each of fiscal
24 years 2017 through 2020”.

1 (B) EXPENDITURE RULES FOR ELIGIBLE
2 COUNTIES.—Section 102(d) of the Secure Rural
3 Schools and Community Self-Determination Act
4 of 2000 (16 U.S.C. 7112(d)) is amended—

5 (i) in paragraph (1)(F)—

6 (I) in the paragraph heading, by
7 striking “FOR FISCAL YEARS 2017 AND
8 2018” and inserting “FOR EACH OF
9 FISCAL YEARS 2017 THROUGH 2020”;
10 and

11 (II) by striking “for fiscal years
12 2017 and 2018” and inserting “for
13 each of fiscal years 2017 through
14 2020”; and

15 (ii) in paragraph (3)(D)—

16 (I) in the paragraph heading, by
17 striking “FOR FISCAL YEARS 2017 AND
18 2018” and inserting “FOR EACH OF
19 FISCAL YEARS 2017 THROUGH 2020”;
20 and

21 (II) by striking “for fiscal years
22 2017 and 2018” and inserting “for
23 each of fiscal years 2017 through
24 2020”.

1 (C) DISTRIBUTION OF PAYMENTS TO ELI-
2 GIBLE COUNTIES.—Section 103(d)(2) of the Se-
3 cure Rural Schools and Community Self-Deter-
4 mination Act of 2000 (16 U.S.C. 7113(d)(2)) is
5 amended by striking “through and for fiscal
6 years 2017 and 2018” and inserting “through
7 2015 and for each of fiscal years 2017 through
8 2020”.

9 (b) EXTENSION OF AUTHORITY TO CONDUCT SPE-
10 CIAL PROJECTS ON FEDERAL LAND.—Section 208 of the
11 Secure Rural Schools and Community Self-Determination
12 Act of 2000 (16 U.S.C. 7128) is amended—

13 (1) in subsection (a), by striking “2020” and
14 inserting “2022”; and

15 (2) in subsection (b), by striking “2021” and
16 inserting “2023”.

17 (c) EXTENSION OF AUTHORITY TO EXPEND COUNTY
18 FUNDS.—Section 304 of the Secure Rural Schools and
19 Community Self-Determination Act of 2000 (16 U.S.C.
20 7144) is amended—

21 (1) in subsection (a), by striking “2020” and
22 inserting “2022”; and

23 (2) in subsection (b), by striking “2021” and
24 inserting “2023”.
