Dear President Biden:

In 2022, the U.S. will be hosting the Summit of the Americas for the first time since the inaugural event in Miami in 1994. From annual events that attract tens of thousands of attendees, such as the Space Symposium in Colorado Springs, to high-profile, one-time gatherings such as the 1997 Summit of the Eight, Colorado routinely and readily accommodates

visitors for events of this scope. Hosting is made easier by the proximity of Denver International Airport, which is conveniently connected to downtown Denver via public transportation and offers nonstop flights to 27 international destinations, including cities across the Americas. We believe Colorado is uniquely equipped to host an event of this size and import. We invite your administration's serious consideration of the proposal.
